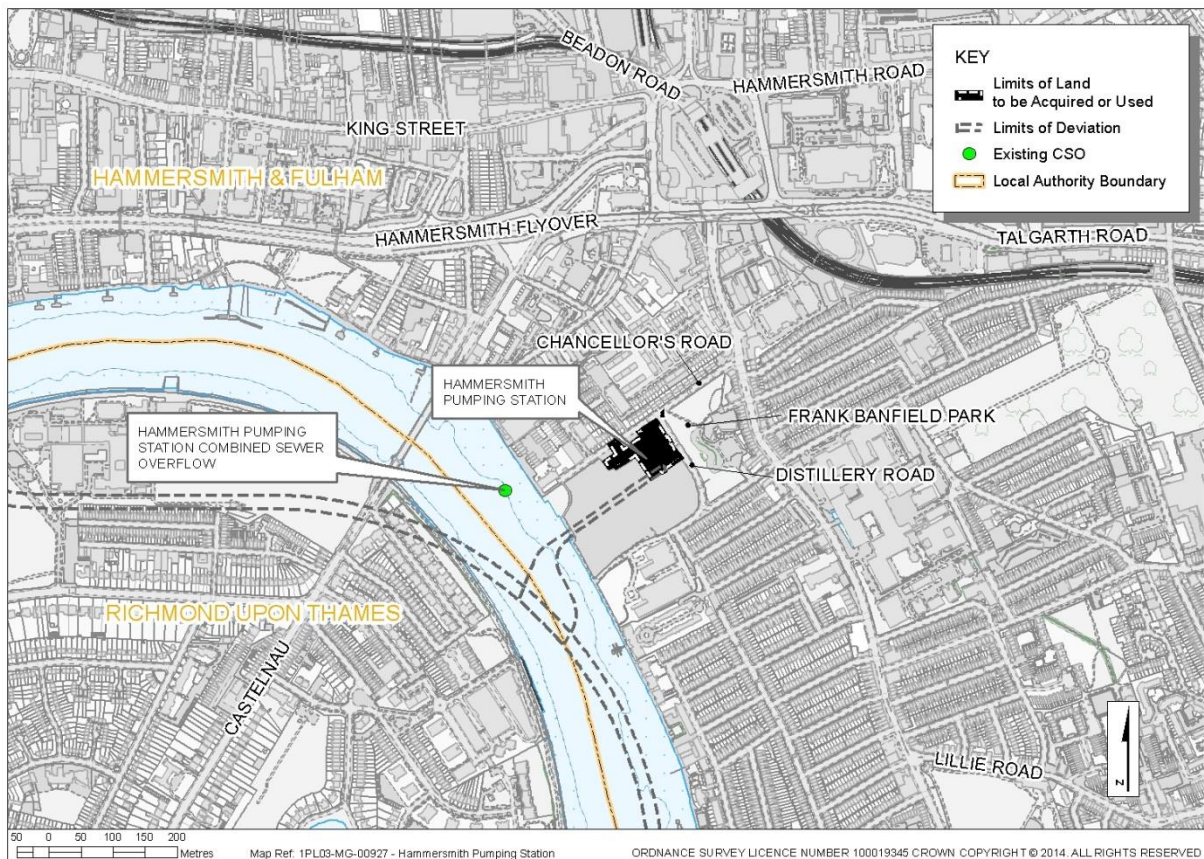

## 1 Introduction

- 1.1.1 All works described in this document are to be managed and performed to meet the health and safety vision of 'Zero Incidents, Zero Harm, Zero Compromise' for the Thames Tideway Tunnel project (the 'project').
- 1.1.2 The *Code of Construction Practice (CoCP)* comprises two parts:
  - a. Part A: General requirements. These measures are applicable project wide.
  - b. Part B: Site-specific requirements. These are site-specific measures where deviations from the general requirements are indicated in Part A.
- 1.1.3 This document forms the *CoCP* Part B for the project works at the Hammersmith Pumping Station site and sets out detailed site-specific measures including working hours, site set-up and servicing arrangements, taking into account environmental matters and consultations with the London Borough of Hammersmith and Fulham and other stakeholders.
- 1.1.4 For ease of reference, this document sets out site-specific issues and deviations from Part A; therefore where no site-specific measures are specified, reference should be made to Part A.
- 1.1.5 A plan of the location of the site is shown in Figure 1.1 overleaf.

Other items	The site offices shall be positioned along the northern boundary of the site to screen Chancellor's Road from construction activities. DCO Requirements secure the preparation of site-specific travel plans. The contractor shall detail measures to prevent parking impacts from shift workers on Distillery Lane and Chancellor's Road.

## 5 Public access, highway and river transport

Site access and gates	The main site entrance shall be from Distillery Road, with right turn in and left turn out.
Traffic management	All vehicles shall enter/exit the site from Fulham Palace Road (A219) and Chancellor's Road, turning into an entrance on Distillery Road. The contractor shall manage vehicle arrivals and departures to minimise potential conflicts with other road users along Chancellor's Road. Two-way operation of Chancellor's Road shall be maintained during the short-term lane closure required to connect utilities. A small section of parking equivalent to one parking space shall be suspended along the southern side of Chancellor's Road. The single yellow line parking restrictions on Distillery Road and Chancellor's Road shall be extended for the duration of the works.
Event restrictions	As per the <i>CoCP</i> Part A.

Control measures The noise and vibration control measures shall be detailed (and may be modified or added to) in Section 61 consent applications to the local authority.	Except for the anchor piles, push piling shall be used unless determined to be impossible. The anchor piles will be installed at a suitable location as far away from the closest sensitive receptors as practicable.  The use of surface cranes shall be minimised outside of standard working hours. The contractor shall implement measures to reduce noise, including using electric gantry cranes where practicable and electric forklifts, particularly when moving and unloading skips.
