<p>Information reviewed/taken into account</p>	<p>The Panel received the decision of the ICC dated 31 May (Information pack 2350-TDWAY-TTTUN-990-ZZ-ZZ—720603).</p> <p>In his decision the ICC referred the case back to the Panel to consider the following:</p> <ol style="list-style-type: none"> 1. Using the results of the noise monitoring, what change has occurred in the noise impact at the property, compared, for example, to previous occasions when you made a claim, and showing how that change is being taken into account by the ICP in reaching its decision; 2. To demonstrate clearly that your personal sensitivity to noise is being taken into account in the decision reached by the ICP.
<p>Decision</p>	<p>The Panel considered the case again, taking into account the matters raised by the ICC. No change to the mitigation awarded was made. A further explanation of the decision making process was given.</p>
