| Further information | In relation to air quality, the measured particulate levels around the site remain significantly below (less than half) the Air Quality Objective levels. |
| required/actions arising | In relation to noise, the review of noise data at the Chambers Wharf site has demonstrated to the Panel that the mitigation measures taken by Tideway reduce to levels which would not ordinarily cause disturbance or impact upon the normal use of the property. The property is substantially shielded by the site offices and acoustic enclosures. Noise levels are not currently anticipated to be high enough at this property to cause an inability to sleep during the day |
