Details of the award	<p>The claimant has discussed with Tideway the previous award that was made to the family in 2018.</p> <p>It would appear that part of the implementation of the award related to rehousing was missed by Tideway. Decision	Proposed mitigation was in PART AWARDED
Details of the award	<p>The claimant identifies that the family is disturbed by noise at all times of the day and night and is also affected by dust from the site. The claimant has made a number of complaints since August 2019 and has provided video evidence dating from July 2019. No medical evidence has been provided.</p> <p>The claimant is requesting a variety of mitigation measures.</p> <p>The Panel made a part award to assist with the noise impacts of the site. The claimant has been informed that the Panel does not make retrospective awards; however, that is not strictly correct. Details of the award	<p>The claim for TAPs was first heard by the Panel on 10 July 2018 and subsequently carried out a site visit to the claimant's property to determine the extent to which noise from the Tideway construction activities was affecting the use of the property.</p> <p>Noting however the location of the property with respect to the site entrance and that works are presently scheduled on a 24/5 basis, but with some additional weekend working, the Panel makes an award as requested.</p>
