

GREENWICH TUNNEL SECONDARY LINING PROGRESS








Air Treatment Unit construction

- MEICA (Mechanical, Electrical, Instrumentation, Control and Automation works) will start in Sept 2023










West tie-in detail


The west tie detail works will start in June 2023. We will saw cut, excavate, remove obstructions and install temporary support sheets. We will then cast the concrete tie in detail in a series of concrete pours, remove the sheets and back fill.






Capping beam installation

These works will begin in June 2023 in the west section and then move to the east. The work involves breaking a section of the existing slab and excavating to depth. We will then crop the river wall piles, fix steel reinforcement, install shutters and cast the wall in a series of concrete pours.







Pre-cast slab cover beam construction

- 5 precast beams are required to cover the Chambers Wharf shaft. Works have started.
- The beams will be constructed on the west side of the acoustic shed where the Slurry Treatment Plant was located.
- The beams weigh between 70t and 175t.
- Works will include shuttering, steel fixing and pouring concrete. A crawler crane and concrete pump will be used as part of these works.
- The beams will then be lifted into position in April 2024.



Completion of secondary lining and shaft strip out


- Once the secondary lining shutters reach the Chambers Wharf shaft they will be removed to surface, dismantled & leave site.
- Secondary lining equipment will then be removed from pit bottom and taken off site.
- Secondary lining equipment will to leave site from August 23.





Installation of shaft benching

- Shaft benching works will start once the shaft strip out is complete.
- These works will start in October 2023.
- The works will be 24 hours a day and will take place inside the acoustic shed.
- Aggregate required for the concrete will be delivered by barge and batched on site.
- The works will include shuttering, steel fixing and pouring 3000m3 of concrete.


COFFERDAM REMOVAL METHODOLOGY



Removal of Cofferdam – Summer 2024 to Spring 2025

- The cofferdam will be removed in the reverse sequence of how it was installed.
- The hinterland and fill will be removed using excavators and material removed by barge.
- The cells will then be excavated and sheets removed in a sequence working from east to west.
- The majority of the sheet piles will be removed using a GIKEN silent piler. The remaining piles that cannot be removed using the GIKEN will be removed using a vibro hammer.





REMOVAL OF SECONDARY GLAZING, BALCONY SCREENS & VENTILATION



We are currently in the process of writing to members of the local community who had secondary glazing, balcony screens or ventilation systems installed.

The letters contain a form where properties can request to have these items removed at a date in the future or left in place after the Tideway works at Chambers Wharf are completed - which will provide further protection for the subsequent residential development.







Framework

Under legal agreement Thames Water have agreed to fund a number of projects in the local area surrounding the Chambers Wharf site. This is set out in with accordance with the details and terms in the agreement.

Key points

- Financial contributions to local infrastructure projects in the area adjacent to Chambers Wharf including local schools, play facilities, transport improvements.
- Terms of reference for the establishment of a Community Liaison Working Group (CLWG) for local residents to find out the latest information and to raise questions and any concerns.
- Terms of reference for the expenditure of a £1m Community Enhancement Fund (CEF) with clear guidance on how local people can submit project ideas, and a how a local panel of stakeholders can oversee the expenditure.
- A set of obligations on the contractor to create local employment and skills outcomes for residents in Southwark.

Section 106 & Community Enhancement Fund Breakdown

- The Unilateral Undertaking signed in 2014 secured approximately an indexed-linked £5,385,000 which has been allocated and being spent on local infrastructure projects.
- The community enhancement fund is £1,000,000 payable annually over 7 years.
- The community enhancement fund has £429,975.00 remaining to spend on local community projects.

Section 106 Project George Row Playground Development

Work was completed on the George Row playground in December 2023. The full cost for the project was £420,000








CEF Project Schools Out @ Salmon Project

The Community Enhancement Fund funded the Salmon Youth Centre in Bermondsey to provide allocated places to Chambers Wharf children providing a total of 304 young people with a really exciting summer of activities with a 1 weekly play scheme, 17 trips, 3 evening clubs and 1 residential.

707 attended throughout the week (116 females and 121 males). They took young people out on trips each day with 17 trips taking place. Young people had the opportunity to visit inflatable parks, bowling, cinema, and several local parks and complete a host of activities.

CEF Project Dickens Estate Hedging Project

A planting day was held on Saturday 10th December 2022 just before the heavy snow came. The mix of native plants evergreen, supports pollinators (bee-friendly). This project also includes 3 years maintance of the hedges covering all 10 blocks on the Dickens Estate and along Jamaica Road costing £63,000.00.



As well as noise reducing, the hedging captures pollution, and will improve and soften the aesthetic of dense urban environment.

The evergreen plant selection will liven up and add colour to the area.

Community Enhancement Fund Voting Event 7 – February 2023
