REMOVAL OF THE ACOUSTIC ENCLOSURE

Now that the civil works within the shaft and culvert are coming to an end, from mid-November, we plan to begin taking down the acoustic enclosure adjacent to Norman Road. This is the large, grey building, shown in the photograph overleaf.

Most of the removal works will take place during normal working hours, Monday to Friday and Saturday morning, but there will be periods of night-time work. This is due to restrictions on any work near the DLR viaduct when trains are running for safety reasons. Some of the equipment needed to dismantle the acoustic enclosure may be noisy.

We are currently in discussion with DLR to confirm the exact extent of works which need to be conducted during nighttime hours and will update residents via email once this is finalised. If you would like to be added to our mailing list email our helpdesk.

We anticipate the noise enclosure removal works will continue until approximately late February / early March although the intensity of the dismantling works will vary during this period. Night-time working will only be required intermittently and not for the entire November to March period.

We will, as always, be using appropriate noise mitigation to ensure we are working within noise limits agreed with the council. Damping down will be used to reduce any dust. The site team will continue to try and minimise disruption, but we understand some people are affected more than others by construction work such as noise and vibration.
