# WEEKLY SITE UPDATE



## THIS WEEK

The site team completed erecting the lifting gantry and successfully installed the first of six precast beams which will cover the shaft (see photograph below).

On the western side of the site, we continued with the capping beam construction, by installing steel reinforcement, carrying out periodic breaking of concrete and cropping piles. The capping beam will connect the new permanent river wall to the existing river wall.

On the eastern side of the site, capping beam and drainage works continued, with periodic breaking.

Inside the acoustic enclosure, we continued the removal of the concrete batching plant and aggregate bay, which involved some breaking. The batching plant was used to mix concrete for the secondary lining and concrete benching. We also progressed with shaft benching works to safely transfer flows through the shaft once the tunnels are operational.

On Saturday and Sunday, we will be working inside the acoustic enclosure on concrete finishing for the benching works, plus installing precast beams over the shaft in extended hours: working up to 5pm.

## **NEXT WEEK**

We will receive deliveries of the other precast beams and will continue with the shaft cover installation.

Specialist repairs are planned for the river-facing acoustic enclosure doors that had some mechanical issues which meant they were unable to be fully closed.

We will be cropping piles, with periodic breaking, for the western side of the site for the river wall capping beam and installing steel reinforcement.

On the eastern side of site, drainage works will continue with periodic concrete breaking and we will be installing drainage pipes. We will also continue with the capping beam construction.

Inside the acoustic enclosure, we will continue shaft benching works, as well as removing the aggregate bay with periodic breaking. Aggregates needed for the work will continue to arrive by barge.

The team will plan any concrete breaking during the day between 9am and 5pm. We continue to use mitigation measures such as noise barriers around any breaking work, plus tools and equipment designed to reduce impacts. We will continue to monitor noise and vibration levels.

Please accept our apologies for any disruption as we continue with these works.

#### **WORKING HOURS**

Due to the current mechanical issues with the acoustic enclosure doors, the site team reduced usual working operations within the enclosure. These would normally be 24 hours a day within the enclosure, with the doors closed from 6pm to 7am. We are also adjusting some interior lighting, where safe to do so, while the doors are unable to fully close.

The table outlines working hours used for the movement of materials onsite outside of the noise enclosure.
