Details of the award	<p>The claimant is requesting an extension of the current two nights respite per week for herself plus a carer as the noise on site is still disturbing her. Apparently, the concrete breaking is ongoing.</p> <p>The ICP has received significant s.61 and noise and vibration monitoring data for the CARRR site. However, the data only extends as far as early January 2024 but the original s.61 from 1st of December 2022 has now been extended until 31st December 2024 as the works are overrunning. The extension refers to the previously approved s.61 and the same works and noise levels are likely to occur. From the s.61 extension, it would appear that major works are still ongoing although mostly during core hours except for the River Wall 925 Removal works which are tide dependent.</p> <p>Based upon the above, the following award is made:</p> <p>The Panel has very carefully considered this application with respect to the on-going works at the site and has taken into account as a precautionary measure, the claimant's existing and present health issues. The Panel has determined to extend the existing award of two nights respite a week at the standard rate for the claimant and a carer until the end of July 2024.</p>

Details of the award	<p>The claimant's wife has come to the ICP describing her husband's health diagnosis and providing details of the medication he is on and requesting a respite break for the project period.</p> <p>The noise report for ICP meeting # 254 was taken into consideration and we are aware of the ongoing Deep Dive works.</p> <p>The Medical Specialist has reported to the Panel on the claimant's current health issues.</p> <p>As the Panel are uncertain as to exactly the type of respite being requested, consideration of the claim is deferred until the ICP Admin can obtain further details, as requested in a separate email.</p> <p><u>PMN</u></p> <p>The Panel has since heard back from the claimant and an award of two days respite a week at the standard rate is made until the end of July 2024. Decision	AWARDED
Details of the award	<p>The Panel is aware of the personal circumstances of the claimant and the location of their property in relation to the CHAWF construction site.</p> <p>Current Award - The Panel acknowledges that the applicant has stated she is now using the previously awarded daily respite. The Panel requests that the applicant liaises with the Tideway mitigation team with regard to production of valid receipts in accordance with Tideway’s Guidelines for Implementation of ICP decisions. The Panel highlight the current award value and that award needs to be taken before 31 May 2024, as detailed in previous ICP minutes. For the avoidance of any confusion that award, which the Panel understands has been partially taken, is at the standard daily rate.</p> <p>New Award – for the period 1 June to 30 September 2024, the Panel awards the applicant, plus other permanent members of the household, the following respite.</p> <ul style="list-style-type: none"> • For adult household members (including a carer) – 2 days respite per week at the standard rate; • For household members of school age – 1 day per week daily respite (during term time) and 2 days per week (during school holiday periods) at the standard rate. <p>The award and daily respite reimbursement shall be in accordance with Tideway’s Guidelines for Implementation of ICP decisions. Documentation evidence shall be provided to confirm those permanently living at the address and the name of the carer and appropriate documentation identifying their appointment as the carer.</p> <p><u>Alternatively</u>, the Panel agrees that the applicant may opt to combine the new awarded daily respite for the period 1 June to 30 September 2024 into a single period of continuous respite to be taken away from her property. If the applicant chooses to take the respite over a single continuous period, the total value of the reimbursement shall not exceed the equivalent total if daily respite were selected. Continuous period respite reimbursement shall be in accordance with Tideway’s Guidelines for Implementation of ICP decisions.</p> <p>All permanent members of the household will need to utilise the same option of respite - i.e. either daily respite or the combination into a single continuous respite period away from the property.</p> <p><u>All awards are subject to Tideway’s Guidelines for Implementation of ICP decisions.</u></p>
