Next week, beginning on Tuesday morning, we will be working from 6 am.

On Monday week, a jack-up barge will be onsite, located in the river to assist in sheet pile removal operations.

THIS WEEKEND

We will be working; trimming and clearing the pavement area in preparation for our landscaping contractor. No cofferdam works will take place over the weekend.

The 24-hour, site-based, security team will be on regular patrol, while site staff will conduct periodic inspections of safety and monitoring equipment.







WORKING HOURS

Normal standard working hours are:

- Monday to Friday: 8am to 6pm
- Saturday: 8am to 1pm

Concrete breaking activities will only be:

- Monday to Friday: 8am to 6pm.
- Saturday: 9am to 2pm (starting and finishing an hour later than standard hours)

We will endeavour to finish all work onsite by 6pm, but other support activities, such as moving materials and pouring concrete, may continue until 8pm.

Tidally affected activities, such as river wall panel installation and cofferdam removal, may take place from 5am to 10pm. This includes excavation, jetty pile removal, cell dismantling, stockpiling materials, lifting activities plus barge loading and movements.
