

Monthly Report of the Independent Compensation Panel Chair

January 2025

The Independent Compensation Panel (the 'Panel') met on three occasions in January 2025.

1. 7 January 2025 (ICP Meeting #272)

Purpose

To determine medical, special and fast-track claims (if applicable).

Panel Members

In addition to the Chair, the Panel was comprised of:

- Noise Specialist; and
- Medical Specialist

The Panel:

- The Panel met via video conference to consider seven claims, two of which were medical claims.
- There was one new claimant in respect of noisy works at the Chambers Wharf site and one claimant requesting an extension to an existing award. The other claimants were requesting new awards.
- The Panel also considered the nature and programme of the marine piling works for Nine Elms Pier (Kirtling Street), due to commence on the 13 January with completion on 17 January 2025.
- These matters were associated with Tideway works at:
 - Chambers Wharf; and
 - Kirtling Street.

The minutes were finalised and uploaded to the Tideway website within two working days of the meeting.

2. 14 January 2025 (ICP Meeting #273)

Purpose

To determine medical, special and fast-track claims (if applicable).

Panel Members

In addition to the Chair, the Panel was comprised of:

- Medical Specialist; and
- Noise Specialist.

The Panel:

- Met via video conference to consider multiple extensions to previous awards (including Fast-Track awards) associated with the Chambers Wharf site which were due to expire at the end of January 2025.
- The Panel determined that all Fast-Track awards and other awards made for claimants living close to the Chambers Wharf site should be extended to the end of July 2025 (or when significant noise from the cofferdam works has ceased) whichever is the sooner.

The minutes were issued within four working days of the meeting.

3. 28 January 2025 (ICP Meeting #274)

Purpose

To determine medical, special and fast-track claims (if applicable).

Panel Members

In addition to the Chair, the Panel was comprised of:

- Medical Specialist;
- Noise Specialist; and
- Compensation Specialists.

The Panel:

- Met via video conference to consider ten claims:
 - one was a claim for loss of rent;
 - five were medical claims (one of which was submitted via Southwark Law Centre);
 - one claim awarded by Tideway under the Fast-Track Respite scheme was ratified by the Panel; and
 - the remaining claims were for various noise respite awards.
- NB: some of the respite claims were from claimants who had already received awards under the Fast-Track respite system but were requesting additional respite.
- These matters were associated with Tideway works at:
 - Chambers Wharf; and
 - One property between Chambers Wharf and King Edward Memorial Park Foreshore.

The minutes were issued within four working days of the meeting.
