




# Tideway activated and testing underway

- We are cleaning up the river!
- ✓ The sites are connected into the new system, and we are protecting the River Thames from sewage pollution
- ✓ Data from November storms 850,000 tonnes of sewage captured by the super sewer in a single 24-hour period (27 November)
- ✓ 'Dry' storm testing undertaken
- Ready for 'Storm' testing
- ✓ Sewer aim to be fully operational in 2025













### **NOISE MITIGATION - Removal / Retention**

Reminder: At the start of the project, we installed a series of noise mitigation measures at various properties in line with our Trigger Action Plan process. As works at Chambers Wharf come towards a close, the noise mitigation previously installed will be removed if this has been requested.

The noise mitigation measures installed were primarily:

- > External balcony screens
- > Internal secondary glazing
- > Ventilation units

We sent out letters in 2023 to confirm relevant recipient's preference on whether they wished to keep these permanently or have them removed.

We now have established what needs to be removed and are preparing for arranging the removal works.

If you have received noise mitigation measures and haven't been sent a letter, **please let us know**.

# If you told us that you want to retain all noise mitigation measures permanently:

 Handover letters have been sent out, which ask you to sign and return. This will look to formalise your acceptance permanently.

# If you told us that you want to have some/all of the noise mitigation measures removed:

 We'll contact you in the coming months to organise the removal of the relevant elements (and make good of any holes, damage etc.). Letters have not been sent out yet as the cofferdam removal works have not been completed.

The freeholders of Axis Court and Luna House have stated **we must remove** the external balcony screens installed, regardless of leaseholder / resident preferences.



It's worth remembering the expected future residential development which will likely take place at Chambers Wharf when considering whether you want to have any noise mitigation removed.

- A fast-track system for mitigation is in place while we remove the cofferdam for previously awarded residents who have a clear view of the site.




### Active Ventilation fans - examples



### **CHAWF – Passive Ventilation**




### **Ventilation - operation**


- Air in the tunnel is normally managed by the creation of a small, negative pressure relative to atmosphere by fans at active ventilation fans sites at the ends of the tunnel(s)
- In normal operation (empty) the tunnel air is changed and treated once per day
- Tunnel typically empty 75% of the year
- In 2025 flows experienced into the tunnel on 20 days (13%) to end of May-25





# INDEPENDENT REVIEW



#### **Purpose**

To provide an independent view on whether it is feasible that Tideway operations, in particular, ground-borne vibration arising from these, could be responsible for perceptible levels of re-radiated noise in residential properties adjacent the tunnel

- Focused on reports of low-frequency noise (LFN) disturbance in three residential properties:
  - Cinnabar Wharf
  - Capital Wharf
  - Shad Thames
- Reviewed:
  - LFN complaints
  - existing measurement reports
  - Tideway operational details and designs



#### **Review Conclusions**

- Strong evidence exists of tonal LFN in the region of 50 Hz
  - previous measurements indicate disturbance is due to structure-borne noise
  - source could be either internal or external to properties
- Reports of disturbance exist in the absence of any activities at Tideway sites (2022 Christmas shutdown)
- Tideway operational data over a 5-month period (Dec '24 to May '25):
  - exhibits no discernible correlation between LFN and status of tunnel ventilation system
  - indicates that LFN varies in perceptibility irrespective of the system status
- No plausible mechanism for flow-induced noise generation within (passive) shaft at Chambers Wharf



#### **Independent Measurements (May 2025)**

- Ground-borne vibration measurements made at 9 locations under various operating conditions:
  - Site 1: Cinnabar Wharf (baseline measurement, river frontage and Thames Path / Wapping High St)
  - Site 2: Abbey Mills Pumping Station (fan cluster, Shaft F and Station F pumps)
  - Site 3: Chambers Wharf (adjacent shaft)
  - Site 4: Greenwich (adjacent fans)
  - Site 5: Carnwath Road (between fans)
  - Site 6: Acton Storm Tanks (adjacent fans)



#### **Independent Measurements (May 2025)**

- 50 Hz tonal vibration measured at Cinnabar Wharf, similar to measured LFN
- No corresponding vibration measured at Tideway sites
- Calculations indicate that:
  - Tideway vibration levels are negligible with regards to perceptible LFN within identified properties
  - this includes the worst-case scenario of a direct preferential propagation path (linear waveguide)



#### **Conclusions**

- Strong evidence exists of tonal LFN in the region of 50 Hz
- No evidence of operational anomalies with measured fans or pumps
- No evidence linking vibration at Tideway sites to that in the vicinity of the identified properties
- Noise and vibration measurements at Cinnabar Wharf:
  - are consistent with reports of the disturbance
  - indicate structure-borne noise from some form of electrical machine(s)
- Further measurements may identify the source, but this would require careful and potentially extensive work,
   e.g. through Environmental Health
- Report in final QA process and due for publication w/c 16 June 2025
