<b>Details related to the decisions</b>	<p><b>CHAWF</b></p> <p>In determining awards for claimants affected by the Thames Tideway works in the Chambers Wharf (CHAWF) site area, the sources of information described below have been considered. Current or particularly relevant information is described more fully.</p> <ol style="list-style-type: none"> <li>1. The most recent s.61 dated 11.12.23 was for the period 1st January 2024 to 31st December 2024 and hence this has expired. However, there is a dispensation in place for the period 1st January 2025 until completion of the works.</li> <li>2. The Engagement Manager for the site has provided regular updates on programme and progress in addition to the Weekly Site Updates.</li> <li>3. The CVB (contractor) site agent has also provided a summary of activities and likely noise levels until the completion of works.</li> <li>4. Chambers Wharf Community Liaison Working Group December 2025</li> </ol>

Normal working hours for other activities are:

- Monday to Friday: 8am - 6pm
- Saturday: 8am - 1pm

Concrete breaking activities will only take place

- Monday to Friday: 8am - 6pm
- Saturday: 9am - 2pm (starting and finishing an hour later than standard hours)

We endeavour to finish all work onsite by 6pm, but other support activities, such as moving materials and pouring concrete, may continue until 8pm.

Tidally-affected activities, such as cofferdam removal, may take place from 5am to 10pm. This includes excavation, cell dismantling, stockpiling materials, lifting activities plus barge loading and movements.

We try to plan our work so noisy activities do not start before 8am or continue after 6pm.

6. In addition to the above, a CHAWF remaining works programme and information has been issued by Thames Tideway Property Management on the

14th of October 2025. This provides progress on the pile removal and indicates that high noise activity could continue on and off, through to now April 2026; a better situation than the previously reported September 2026.



It should also be noted that the ICP makes regular visits to particularly active sites and CHAWF is one of those. A site visit to CHAWF was carried out on Thursday 7th of August 2025 at which time, vibratory pile removal from toe (partial) and complete pile removal by crane, were witnessed from the closest possible locations as representative of residents affected by the works. What was witnessed was the removal of intermediate piles, i.e. every other pile had already been removed. Due to the extra friction likely to be associated with initial pile removal from a complete row, noise levels from the vibratory removal tool are acknowledged as potentially higher. A further site visit was carried out on Friday 31<sup>st</sup> of October 2025 where low level activities were observed and the programme discussed with the contractor's representatives.

The recommendations made by the ICP are therefore based upon a review of all the available information including personal on-site observations from site visits.

The Panel is aware of the ongoing works at the CHAWF site both in terms of written information and weekly reports but also from numerous site visits. Whilst elements of the current works are noisy, particularly during pile removal or any residual concrete breaking, high levels of noise do not occur all the time and noise from the site is mostly much quieter. As for the previous meeting, it is notable that, of the 410 sheet piles, only 165 have been extracted and it is also understood that no further extractions will occur in 2025.

Details of the award	<p>The claimant is requested to read the details of the site visit and construction activities on page 1 of the Minutes.</p> <p>No claim form has been received to date.</p> <p>This claimant has now come back to the ICP requesting noise cancelling headphones which she had not previously requested as she had some earbuds, but these have been lost.</p> <p><b>The Panel has determined to make an award of one pair of noise cancelling headphones to a maximum cost of £100 to aid working from home. Additionally, the respite award is increased to two days a week at the standard cost until the end of March 2026, at which time the Panel will reconsider all awards.</b></p> <p><b>Claimants are reminded to read the guidance information below.</b></p> <p><b><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></b></p>

Details of the award	<p>The claimant is requested to read the details of the site visit and construction activities on page 1 of the Minutes.</p> <p>This claimant is claiming:</p> <ul style="list-style-type: none"> <li>• Respite for four people, two days per week at £30/person/day, consistent with previous awards, to allow my family regular relief from ongoing noise and disruption.</li> <li>• Accumulation of daily respite over weekly or monthly periods, enabling unused portions to fund larger respite activities, such as family outings or medical appointments.</li> <li>• Occasional overnight stays included within the accumulated allowance, to provide essential periods of rest and recovery.</li> <li>• Recognition that the long-term, continuous nature of these works (since 2016, originally expected to finish two years ago) justifies flexible and sufficient respite support.</li> <li>• Consideration of medical and health-related impacts.</li> <li>• Pre-approval guidance and clarity from Tideway for accumulated activities, so that respite can be planned confidently without risk of non-approval.</li> <li>• Allowing respite claims to cover multiple activities across a week or month, even if individual receipts are less than the maximum daily allowance, ensuring the full benefit of the award is applied to meaningful respite.</li> </ul> <p>Additional notes:</p> <ul style="list-style-type: none"> <li>• <i>Weekly updates from Tideway confirm that noisy construction activities continue at the site, including cofferdam removal, pile extraction, and thermal cutting, often outside standard working hours (for example, 5am–10pm during tidally affected activities, newsletter 5 December 2025).</i></li> <li>• <i>I am happy to provide receipts, diaries, or medical evidence on request, but these have already been submitted to Tideway in previous claims.</i></li> </ul>

	<p>The Panel has determined that, having taken all of the available information into account, the award is as follows, cross-referenced against the various aspects of the claim:</p> <ol style="list-style-type: none"> <li>1) <b>Respite for four people</b> - The Panel, having reviewed the forward programme of construction works, has determined to make an award of two days respite a week for the claimant and all family members at the standard cost until the end of March 2026, at which time the Panel will reconsider all awards.</li> <li>2) <b>Accumulation of daily respite over weekly or monthly periods</b> – Respite payments may be accumulated over a calendar month and used against specific larger respite activities which must be pre-approved by the Tideway Mitigation team.</li> <li>3) <b>Occasional overnight stays</b> – The Panel has determined that no additional award is made in respect of occasional overnight stays. <b>Details of the award</b>	<p>The claimant is requested to read the details of the site visit and construction activities on page 1 of the Minutes.</p> <p>This claimant's last claim was heard at ICP meeting # 290 held on the 12<sup>th</sup> of August 2025. At that meeting, the following was awarded:</p> <p><b><i>The Panel has considered all of the available information and has determined that as an exception, based on the claimant's health issues, the claimant and her family are awarded access to two nights' accommodation for all family members until the end of December 2025, or to when noisy works cease, whichever is the sooner. The claimants should engage with the Tideway Mitigation team to agree costs.</i></b></p> <p>She has now come back to the ICP.</p> <p><b>The Panel has considered all of the available information including the construction programme and has determined that, as an exception based on the claimant's health issues, the claimant and her family are awarded access to two nights' accommodation per week for all family members until the end of March 2026, at which time the Panel will reconsider all awards. 	<ul style="list-style-type: none"> <li>• An extension of my current respite award, including two days of respite and one overnight stay per week.</li> <li>• An increase in respite to three days per week, due to the amount of time we must spend outside the home during Tideway working hours.</li> </ul> <p><i>I appreciate the consideration already given to my circumstances and understand the complexities involved. However, the impact on my health now warrants additional intervention. I remain committed to working constructively with Tideway and the Panel toward a fair and compassionate solution. I am also willing to present my case via video conference if helpful.</i></p> <p>The Panel has considered all the information available, including previous health information for the claimant, and has determined to continue the existing award of 2 days respite/week at the standard cost and one night's overnight accommodation/week. Details of the award	<p>The claimant is requested to read the details of the site visit and construction activities on page 1 of the Minutes.</p> <p>This claimant has now come back to the ICP requesting the following:</p> <ul style="list-style-type: none"> <li>• <i>Daily respite (£30 per day) due to the ongoing disruption and its impact on my physical and mental health.</i></li> <li>• <i>Holiday respite, as a short break away from the noise and vibration would support my recovery and wellbeing.</i></li> <li>• <i>Mitigation equipment, including:</i> <ul style="list-style-type: none"> <li>o <i>Blackout blind</i></li> </ul> </li> </ul> <p><i>These measures would significantly improve my living environment and help reduce the health impacts caused by the construction works.</i></p> <p><i>I am <u>not</u> requesting rehousing.</i></p> <p><b>The Panel has considered all the information available for the claimant and has determined to make an award of 2 days respite/week at the standard cost for all family members. The award is extended until the end of March 2026, at which time the Panel will reconsider all awards.</b></p> <p><b>The Panel has determined that the request for holiday respite is not awarded, although the claimant may accumulate their respite award in any calendar month for longer breaks away from her property.</b></p> <p><b>With respect to the request for blackout blinds, Tideway has a separate procedure and the claimant is encouraged to engage with Tideway to determine whether this would be available.</b></p> <p><b>Claimants are reminded to read the guidance information below.</b></p> <p><b><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></b></p>

Details of the award	<p>The claimant is requested to read the details of the site visit and construction activities on page 1 of the Minutes.</p> <p>At ICP meeting # 290 held on the 12th of August 2025, the claimant's award was amended as follows:</p> <p><b><i>The Panel is aware that the works at CHAWF are not persistent or continuous but occasional and sporadic with significant periods of limited noise. The Panel has taken into account all of the information available and has determined that an award of one day of respite a week for all family members at the standard cost is awarded. The award is until the end of December 2025, or to when the noisy works cease, whichever is the sooner.</i></b></p> <p>The claimant appealed this award and was requesting to revert to two days a week. She has provided nine videos taken from her balcony but none of these are indicating excessive noise levels.</p> <p>This appeal was considered at ICP meeting # 291 held on 26<sup>th</sup> of August 2025 and the following was agreed:</p> <p><b><i>The Panel has considered all of the information available to it and has determined that the existing award is not amended.</i></b></p> <p>The Panel is aware of the ongoing works at the CHAWF site both in terms of written information and weekly reports but also from numerous site visits. Whilst elements of the current works are noisy, particularly during pile removal or any residual concrete breaking, high levels of noise do not occur all the time and noise from the site is mostly much quieter. As previous meeting, it is notable that, of the 410 sheet piles, only 165 have been extracted and it is also understood that no further extractions will occur in 2025.</p> <p>From site visits and site/programme information, we are aware of the low level of activity at the site at the current time and hence the disturbance and activities description provided by the claimant does not fully replicate what has been happening on site recently.</p>

	<p>The claimant has responded to two assertions made by the ICP that she objects to and has provided nine videos taken from her balcony but none of these are indicating particularly excessive noise levels.</p> <p>ICP Response to the above: The nine videos have been re-examined and there is no evidence that they were taken from within the property. There are very clear views of the site with no window edges or curtains or other evidence that they were taken from within the property. Also, how the sound is heard indicates a freefield location.</p> <p>The ICPs observations as to the intensity of the works at the CHAWF site are based upon multiple site visits, programme and activity reports and discussions with the site Team.</p> <p>The claimant is also challenging working hours and that these should only commence from 09:00 hrs. Details of the award	<p>The claimant is requested to read the details of the site visit and construction activities on page 1 of the Minutes.</p> <p>The ICP last dealt with the claimant at ICP mtg # 261 held on 29<sup>th</sup> of July 2024.</p> <p>She was awarded:</p> <p><b><i>The Panel has considered this claim very carefully with respect to the information provided by the claimant, in particular her health issues, and also the very detailed information with respect to site activities and has determined that access to alternative office accommodation should be provided three days a week until the end of September 2024. The claimant should engage with the Tideway Mitigation Team with respect to costs etc. The request for the costs of food and drinks is not approved as the Panel consider that this would be part of normal daily costs.</i></b></p> <p><b><i>The Panel has determined not to make an award of overnight accommodation for Friday nights as the Panel considers that the above award and the fast-track respite award should adequately address the claimant's concerns, noting that noisy works are not presently scheduled to commence until 0900 hrs on Saturdays and will cease at 1800 hrs on the Friday.</i></b></p> <p>The Panel has considered this latest claim very carefully and has taken into account the claimant's revised working arrangements. Accordingly, the Panel has determined to award access to alternative office accommodation for two days a week until the end of March 2026.
